#### **Development Will Increase Flood Risk Elsewhere**

The major development sites in Formby already suffer from surface water flooding and are effected by high ground water. Developers plan to push more water into a smaller space and store it in or on already saturated ground. Sefton Planners seem content to allow them to do this. The new houses will be protected by raising finished floor levels above potential flood water (residual risk).

If you have photographic evidence of flooding ideally with the time and date of the event please could you send them to Formby Residents' Action Group so we might include them in our objection when the planning application is finally submitted.
